The bid documents should have been signed on each page with name & designation and stamped. Document to be submitted online duly signed and stamped and scanned copy.**

**7.0** The cost on account of preparation and submission of Bid, negotiations, discussions etc., as may be incurred by the Bidder in the process, are not reimbursable by the owner, and the owner will in no case be responsible or liable for these costs, regardless of the conduct or outcome of the bidding process.

**8.0** All the information in the bid shall be in English, failure to comply will disqualify a bid.

**9.0** In the event of award of contract, the same shall be executed on firm price basis as per conditions.
