

**INVITATION FOR BIDS FOR SUPPLY OF FLY ASH  
FROM NTECL'S VALLUR THERMALPOWER PROJECT**

**1. Introduction**

NTPC TAMILNADU ENERGY COMPANY LTD., (henceforth referred to as NTECL Vallur which expression shall unless repugnant to the context or meaning thereof be deemed to include its successors and permitted assigns) intends to promote utilization of fly ash as resource material. To facilitate this, NTECL Vallur wishes to supply fly ash for a period of 01 year. NTECL Vallur thus invites bids from eligible and interested **end users/ industry only and not for traders** for supply of fly ash from the units of NTECL VALLUR THERMAL POWER PROJECT (henceforth referred to as NTECL Vallur) as mentioned below:

**2. Scope of Supply:**

- a) NTECL Vallur invites bids as specified in the e-tender catalogue – document/ bid document for the sale of Fly Ash to the interested eligible **end users/ industry** (Industries engaged in manufacturing of products using fly ash like Cement, RMC (Ready Mix Concrete), RCC Pipes, and Asbestos sheets and fly ash based building products. Industries doing Classification **and/or** Grinding of **dry fly ash**, adding as Additives, or any other value addition **to the building products by addition of fly ash** are considered as Industry) from the designated delivery point (s) ie Chutes of Ash Silos, as detailed in the bid document, in the buyer's bulkers only on 'as available' basis.
- b) Total quantity of fly as in MT from the station/ project is available for sale tentatively on yearly basis as per details given hereunder:

#### 4. Eligibility for price-bid participation

Only those buyers who:

- (i) Are registered with MSTC as per specified guidelines for registration, displayed on MSTC website [www.mstcecommerce.com](http://www.mstcecommerce.com) and
- (ii) Have remitted UNCONDITIONAL EMD as per the applicable terms,
- (iii) Have submitted qualifying documents at NTECL as per Annex-1A before the last day of submission of documents as per para 3.0 and cleared by NTECL as per terms and conditions of the e-tender/bid document along with all relevant Annexures duly filled say 'no' deviation statement, Fraud prevention policy, etc

shall be eligible to participate in the price-bidding process. **No EMD shall be enclosed along with qualifying requirement documents to be submitted to NTECL.**

#### 5. Qualifying Requirements for the End users /Industry

- a) Bidder should be a firm or a company or a JV/Consortium.
- b) Bidder should be an End User / Industry (They are directly engaged in manufacturing of products using fly ash like Cement, RMC (Ready Mix Concrete), RCC Pipes, and Asbestos sheets and fly ash based building products. Industries doing Classification, Grinding of **dry fly ash**, Adding Additives, or any other value addition **to building products by adding fly ash** are considered as Industry.).
- c) The average turnover of the bidder for the last three financial years should be
  - (i) **For Quantity up to 12,000 MT per Annum:** Total Value at the floor price as decided by **NTECL** for 12000 MT subject to minimum of Rs 3 Lakhs per annum.
  - (ii) **For quantity between 12,000 MT to 50,000 MT:** Total Value at the floor price as decided by **NTECL** for 50,000 MT subject to minimum of Rs 10 Lakhs per annum.
  - (iii) **For quantity between 50,000 MT to 2,00,000 MT per Annum:** Total Value at the floor price as decided by **NTECL** for 2,00,000 MT subject to minimum of Rs 25 Lakhs per annum.
  - (iv) **For quantity more than 2,00,000 MT per Annum:** Rs. Total Value at the floor price as decided by **NTECL** for 3,00,000 MT subject to minimum of Rs 50 Lakhs per annum.
- d) In case the bidder is a Joint Venture/Consortium all the partners of the Joint Venture/Consortium shall be collectively required to meet the turnover criteria.
- e) The banned bidder by Government / any NTPC Thermal power plant / NTECL for any reason including committing fraud etc shall not be eligible for bidding .

Note:-

In case of Manufacturers/End Users, the said agencies are also required to submit statutory license from government/Work Orders/Certificates from the client to prove

that they are involved in manufacturing work using fly ash.

The bidder shall also submit an undertaking that the fly ash issued by NTECL to the bidder shall be used by himself only (mentioning the product to be manufactured) and not for trading purpose or transfer of ash to any other party and if found violating the said condition during the execution of contract, then NTECL is free to take suitable action against the bidder including banning up to three years as deemed fit.

**Note: -Balance Sheet**

Audited balance sheets or Chartered Accountant certified showing the business turnover and profit & loss account for last three financial years of the company on whose turnover qualification has been sought should also be submitted along with the proposal. (Individual or a partnership firm or a company not falling under statutory requirement of audit, has to submit a certificate from Chartered Accountant certifying the average turnover of the last three Financial Years indicating the year wise turnover).

**6. Undertaking of Utilization of Ash:**

Bidder shall submit an undertaking of utilizing the Fly ash in Cement, Construction or any other Ash based product/ industry only (Annex-IV).
